Students must return requested information within 30 days of the first day of classes in the student's initial semester of attendance for the current school year. Failure to provide required documentation will result in the withdrawal of the financial aid package. Institutional and Campus Based Aid will subsequently be awarded on an availability basis.

If any of these documents are missing or the tax returns are not signed, we will be unable to proceed.
